



### FMU (Full Medical Underwriting):

- This form of underwriting is particularly beneficial for those with existing medical conditions.
- Customers provide their full medical history
- If terms can be offered, there may be specific surcharges applied to their cover from the outset.

- A moratorium sets out a waiting period for pre-existing medical conditions.
- Cover will begin as long as you're symptom-free, and have not needed any treatment or medical advice for a pre-existing condition for a rolling two years.
